

VILLAGE OF EDGERTON ORDINANCE NO. 970

ORDINANCE ESTABLISHING THE SALARIES AND WAGES FOR THE EMPLOYEES OF THE VILLAGE OF EDGERTON, OHIO, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Edgerton, a statutory Village located in Williams County, Ohio employ full-time and part-time employees, and

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Edgerton, Williams County, Ohio that:

Section 1: The following salaries and wages, effective December 27, 2015, are hereby adopted:

Section 2: That the Mayor and Village of Edgerton Council, shall be solely responsible for administering employee's wages.

Section 3: The OPERS pickup plan previously adopted by the Village of Edgerton is repealed effective December 27, 2015. An adjustment to employees' wages for those employees who participated in the OPERS pickup plan will be made at seven percent (7%) effective December 27, 2015.

Section 4: All full time hourly and salary employees shall receive a three percent (3%) increase in their wages effective December 27, 2015, with the exception of the Firefighter Officers and Assistant Fire Chiefs annual salary rate. The Fiscal Officer's base rate will be \$46,000 annually.

Section 5: Volunteer Firefighters hourly rate shall be moved from \$9.00 an hour to \$10.00 an hour.

Section 6: Excluding the volunteer fire department employees, all hourly paid employees shall be paid time and one-half multiplied by their base wage rate for any hours worked in excess of forty (40) hours per week.

Section 7: Excluding the Volunteer Firefighters, Firefighter Officers, and Assistant Fire Chief, the wages for salaried personnel are paid bi-weekly and are calculated on the basis of 2080 hours per calendar year, recognizing that there will be, on occasion, a year with 27 pay periods.

Section 8: This ordinance shall supersede any prior legislation that conflicts with the terms contained herein.

Section 9: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the Village and for the further reason that the immediate effectiveness of this Ordinance is necessary to enable compensation to Village employees consistent with this ordinance; wherefore, this Ordinance shall be in full force and effect from and immediately after its passage.

Section 10: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that results in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Revised Code of Ohio.
